

## Syllabus for ESI 6555, Systems Management

Catalog Description – Systems engineering is a discipline that addresses the management of systems of increasing complexity in military, industrial, commercial, and civil areas. This course will acquaint students with concepts of systems and the role systems engineering plays in their development. It will also provide a basic framework for planning and assessing system development and how systems analysis methods and techniques are integrated within the systems engineering process. (3 credit hours)
