Course Description

This is a 3-credit PhD level course that provide modern treatment of linear programming, network optimization, and integer programming. Special attention will be paid to theoretical derivation of the simplex method and duality theory.

Course Pre-Requisites / Co-Requisites

You are expected to be thoroughly comfortable with undergraduate linear algebra, calculus and analysis, and basic proof techniques. Some familiarity with programming (python, Matlab, or C/C++) is also expected.

Course Objectives

- Introduction to fundamental concepts in optimization such as convexity, duality, complexity, etc.
- Mastery of the theory of linear programming including polyhedral theory, theorems of alternatives, simplex algorithm, duality etc.
- Exposure to large-scale linear programming models and algorithms, network models, and interior points methods.
- Model real-world decision problems mathematically and solve realistic-scale linear programs arising in various applications via Gurobi.
